• <u>Bid Document Modification</u>

Section 410 Article 5.01 -

The bid form has been updated to replace bid item #7 with a "Cut in 12" Tee with 12" Butterfly Valve, complete in place. This will include the 12" Butterfly Valve and all work & appurtenances that are need to install the 12" by 12" Tee. The 12" by 12" Tee itself will be included under bid item #5 Mechanical Joint Compact Fittings – Naked. The water main has two inline valves with no services in the section of the cut in Tee.

The bid for has been updated to clarify bid item #3. Bid item #3 "18" Water Main Bore, DIP PC 350 Installed complete in place & Including Encasement shall be renamed to "18" Water Main Bore, Installed Complete In Place & Including Encasement". This item shall include the cost of the bore and all items needed to install the water main, including but not limited to casing spacers, locking gaskets, & ext. This item does not include the cost of the 18" DIP Water Main.

General Questions

Bid item #12 - This item does include the 18" Butterfly Valve and Plug. This item is included incase the project that is currently planed in place the valve does not complete the work before this project is ready for it. This item does also include an anchor collar.

Working Area For the Bore – Both property owners are aware of this project and are happy with it. There will be room for the boring machine. The property owners are willing to work with us for what space is need to complete the work.

Bore Location – The vertical location of the bore can be adjusted on the south end of the project. The minimum distance under I49 Highway must not be reduced.
